For those of you who do not live within a formal HOA, the responsibility for enforcement falls on your Filing's Approval Authority (AA). If you do not have an active AA, it falls on you the individual homeowner. Unfortunately, MSCA does not have the legal means to enforce covenants but this year one of our goals is to advise homeowners on how to re-activate or form an AA within their Filing. We will also advise homeowners on how they can enforce covenants.

As I always say, "I hate covenants for me, but I love that my neighbors have them". Falling down fences, trailers parked in a front yard, and junk stored on the side of a home don't add value to anyone's home. Neighborhoods where residents abide by the covenants not only make them look nice they also have higher home values. 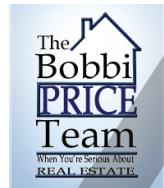
