This Amendment to Declaration of Covenants, Conditions and Restrictions for Longview at Mountain Shakinws is made as of November <u>24</u>, 1997 by Ute Valley, LLC, a Colorado Limited Liability Company ("Declarant").

WHEREAS, pursuant to Section 10.6 of Article X of the Declaration, the Declarant has the right to amend the Declaration during the ten year period following the recordation of the Declaration in the real property records of El Paso County, Colorado;

WHEREAS, Declarant desires to amend the Declaration regarding the height restrictions contained in the Declaration;

NOW, THEREFORE, the Declarant under the Declaration and pursuant to Section 10.6, Article X of the Declaration, hereby declares that <u>Section 6.4(a)(iii)</u>. <u>Building Requirements: Height Restrictions</u> of the Declaration is hereby deleted in its entirety and the following language is substituted in its place:

"(iii) <u>Height Restrictions</u>. No dwelling or other structure shall exceed thirty (30) feet in height, as measured in accordance with the applicable El Paso County Regional Building Department and Zoning Administration Office regulations under the Hillside Overlay Area ordinances."

This Amendment shall be completed and effective upon the execution and recording hereof and the terms and conditions hereof shall be binding upon all Owners of Lots within the Property which is encumbered by the Declaration.
